

International (Non UK Runners) Terms and Conditions for accepting a Golden Bond place to run the TCS London Marathon (April 21st 2024) for Action on Pre-eclampsia (APEC)



Non UK Runners Fundraising Terms and Conditions 2024 – EARLY BIRD CLOSES 1ST JUNE 2023

- **EARLY BIRD 2024 total fundraising pledge £2100 (AFTER 1ST JUNE runners will be asked to raise £3000)**
- Early bird applications received by 1st June -£100 administration donation + **raise £1000 by 1st January 2024** and an additional **£1000 by 31st May 2024** - Total donation amount £2100
- **Standard overseas runner sponsorship for 2024** £100 admin donation, **£1500 by January 1st 2024** and **£1500 by May 31st 2024** – total donation amount £3100

The non-refundable administration donation (£100) is required to secure your gold bond place. **This donation does not count toward the required fundraising target** as it is needed to cover some of the costs of the gold bond place already paid for by the charity. **Once the administration donation is received your place is secured.**

Sponsorship

- The administration donation is required to reduce losses to APEC, should runners drop out. London Marathon places have to be purchased and as a small charity with limited funds, we must work to minimise losses. If APEC declines your application to run then this will be refunded
- If APEC offers you a place then this will not be refundable under any circumstances.
- Should you drop out after 14th January 2024, donations/sponsorship (on top of the £100 non-refundable admin donation) are only refundable on receipt of a doctor's note as after this date, places cannot be transferred.
- Failure to pay any sponsorship by the deadlines agreed could forfeit your place and the marathon company will be informed for future information. If APEC have concerns about your fundraising plans, we will discuss this with you and help to get you back on track, if however, there is insufficient progress we will withdraw your place.
- If you fail to raise the minimum sponsorship by the deadlines detailed above you are liable to submit the outstanding payment shortfall personally.
- It is the runner's responsibility to organise appropriate fundraising activities. APEC will support as much as possible and may ask at any time for a clear fundraising plan. If you fail to be transparent about fundraising or raise the required amount of sponsorship after the 31st May 2024 APEC will not allow entry into future London Marathons and will inform Virgin. APEC will remind everyone who has not donated the full pledged amount in June 2024 as a courtesy. If, however, APEC receive no positive response our policy is to inform the London Marathon organisers. Please make every effort to raise the required amount as APEC would very much regret to take this action. Further fundraising above your option is discretionary, but all funds raised are much appreciated as they support the work we do to support those with pre-eclampsia and campaign for awareness.
- I hereby confirm that I am 18 or over and understand the risk involved in undertaking this event. I therefore do not hold APEC or any of its representatives responsible for any injury/damage or illness sustained to me or my property, how so ever caused, as a result of this event.
- If I am unable to participate in the London Marathon 2024 due to illness or injury I understand that my administration donation cannot be refunded by APEC. I might have the possibility to use the place for the next London Marathon, however I understand that I will have to raise at least 50% more than the required pledge.
- If I do not take part due to illness or injury, I understand that I do not have to raise the minimum sponsorship target, but if I can donate money to APEC, I will.
- I understand that APEC is not obliged to carry over my place to the next London Marathon, if I am unable to run in the 2024 London Marathon due to injury.

External Factors

- If requested, APEC will try to refund any money donated regarding the marathon if a place gets rescinded for any reason, although APEC cannot be held responsible for any external factors.
